WHEREAS the Publisher holds the rights granted under this License

AND WHEREAS the Licensee desires to enable the Licensee to use the rights and the Publisher desires to grant to the Licensee the license to use the rights for the Fee, subject to the terms and conditions of this License.

IT IS AGREED AS FOLLOWS: -

1. KEY DEFINITIONS

1.1 In this License, the following terms shall have the following meanings: -

Authorized Users current members of the faculty and other staff of the Licensee (whether on a permanent, temporary, contract or visiting basis) and individuals who are currently studying at the Licensee, who are permitted to access the Secure Network from within the Library Premises or from such other places where Authorized Users work or study (including but not limited to Authorized Users' offices and homes, halls of residence and student dormitories) and who have been issued by the Licensee with a password or other authentication together with patrons not affiliated with Licensee who are physically present at Licensee's site(s) ("walk-ins").

Commercial Use Use for the purposes of monetary reward (whether by or for the Licensee or an Authorized User) by means of sale, resale, loan, transfer, hire or other form of exploitation of the Licensed Material. Neither recovery of direct costs by the Licensee from Authorized Users, nor use by the Licensee or by an Authorized User of the Licensed Material in the course of research funded by a commercial organization, is deemed to be Commercial Use.

Electronic Reserve Electronic copies of Material made and stored on the Secure Network by the Licensee for use by students in connection with specific courses of instruction offered to its students.

Fee	The Fee set out in Schedule 2 or in new Schedules to this License which may be agreed by the parties from time to time.
Library Premises	The physical premises of the library or libraries operated by the Licensee, as specified in Schedule 3.
Licensed Material	the electronic material as set out in Schedule 1 or in new Schedules to this License that may be agreed by the parties from time to time including such ancillary Material that are owned or controlled by the Publisher and produced specifically to complement, supplement and support the said electronic material or any part of the same including podcasts, data sets, blogs, images, music, games, tests and quizzes.
Secure Network	A network (whether a standalone network or a virtual network within the Internet) which is only accessible to Authorized Users whose identity is authenticated at the time of log-in and periodically thereafter consistent with current best practice, and whose conduct is subject to regulation by the Licensee.
Server	The server, either the Publisher's server or a third party server designated by the Publisher, on which the Licensed Material are mounted and may be accessed.
Virtual Learning Environment	A software system designed to manage and support teaching and learning in education, including systems variously referred to as Course Management Systems, Learning Management Systems, Learning Support Systems, Managed Learning Environments, and similar names.

2. AGREEMENT

- 2.1 The Publisher agrees to grant to the Licensee the non-exclusive and non-transferable right, throughout the world, to give Authorized Users access to the Licensed Material via a Secure Network for the purposes of research, teaching and private study, subject to the terms and conditions of this License, and the Licensee agrees to pay the Fee.
- 2.2 This License shall commence at the date of this Agreement and shall remain in full force and effect without limit of time unless terminated under the provisions of clause 10 of this License.
- 2.3 The Publisher grants the Licensee a nonexclusive, royalty-free, perpetual license to use any licensed content that is including within this Agreement. Such use shall be in accordance with the provisions of this Agreement, which provisions shall survive any termination of this Agreement.
- 2.4 Except in the case of termination for cause, the Publisher shall provide the Licensee with access to the Licensed Material in a manner and form substantially equivalent to the means by which access is provided under this Agreement. If access to the Licensed Material is changed to a manner and form that is not substantially equivalent to the means by which Access is provided to under this agreement, the Publisher will deliver acceptable digital files

to the Licensee of the licensed content without fee.

3. USAGE RIGHTS

3.1 The Licensee, subject to clause 6 below, may:

3.1.1 Load the Licensed Material on the Licensee's server on the Secure Network.

3.1.2 make such local electronic copies by means of cacheing or mirrored storage of all or part of the Licensed Material as are necessary solely to ensure efficient use by Authorized Users and not to make available to Authorized Users duplicate copies of the Licensed Material;

3.1.3 allow Authorized Users to have access to the Licensed Material from the Server via the Secure Network;

3.1.4 display or download the Licensed Material for the purpose of internal marketing or testing or for training Authorized Users or groups of Authorized Users.

3.2 Authorized Users may, in accordance with the copyright law of the United States and subject to clause 6 below:

3.2.1 stream, display, publicly perform, or exhibit the Licensed Material for classroom teaching, research, presentations, and educational non-commercial multimedia projects for use in educational institutions, provided no admission or other fees are charged for public viewing.

3.3 Nothing in this License shall in any way exclude, modify or affect any of the Licensee's statutory rights under the copyright laws of the United States.

4. SUPPLY OF COPIES TO OTHER LIBRARIES

4.1 Notwithstanding the provisions of Clauses 3.1 and 3.3, it is understood and agreed that neither the Licensee nor Authorized Users may provide, by electronic means, to a user at another library a copy of any part of the Licensed Material for research or private study or otherwise.

5. COURSE PACKS, ELECTRONIC RESERVE & VIRTUAL LEARNING ENVIRONMENTS

5.1 The Licensee may, subject to clause 6 below, link to or incorporate parts of the Licensed Material in Electronic Reserve collections and in Virtual Learning Environments on the Secure Network for the use of Authorized Users in the course of instruction, but not for Commercial Use. Each such item shall carry appropriate acknowledgement of the source, listing title and author of the extract, title and author of the work, and the publisher. Copies of such items shall be deleted by the Licensee when they are no longer used for such purpose.

6. PROHIBITED USES

6.1 Neither the Licensee nor Authorized Users may:

- 6.1.1 mount or distribute any element of the Collection on any electronic network accessible to parties who are not Authorized Users, including without limitation the Internet and the World Wide Web;
- 6.1.2 use all or any part of the Collection for Commercial Use;
- 6.1.3 copy, transmit, modify, distribute, sell, or create derivative works from the Licensed Material except as expressly permitted under applicable law or as described herein;
- 6.1.4 reverse engineer, decompile, alter, abridge or otherwise modify the Licensed Material or any part of them for any purpose whatsoever, except as expressly provided in this License;
- 6.1.5 burn Licensed Material to disk or flash memory;
- 6.1.6 transfer, assign, or sublicense this license.
- 6.2 The Publisher's explicit written permission must be obtained in order to:
 - 6.2.1 use all or any part of the Licensed Material for any Commercial Use;
 - 6.2.2 systematically distribute the whole or any part of the Licensed Material to anyone other than Authorized Users;
 - 6.2.3 publish, distribute or make available the Licensed Material, works based on the Licensed Material or works which combine them with any other material, other than as permitted in this License;
 - 6.2.4 alter, abridge, adapt or modify the Licensed Material, except to the extent necessary to make them perceptible on a computer screen or as otherwise permitted in this License, to Authorized Users.

7. PUBLISHER'S UNDERTAKINGS

- 7.1 The Publisher warrants to the Licensee that the Licensed Material used as contemplated by this License do not infringe the copyright or any other proprietary or intellectual property rights of any person. The Publisher shall indemnify and hold the Licensee harmless from and against any loss, damage, costs, liability and expenses (including reasonable legal and professional fees) arising out of any legal action taken against the Licensee claiming actual or alleged infringement of such rights. This indemnity shall survive the termination of this License for any reason. This indemnity shall not apply if the Licensee has amended the Licensed Material in any way not permitted by this License.
- 7.2 The Publisher shall:
 - 7.2.1 make the Licensed Material available to the Licensee from the Server via the Internet access to which is authenticated as specified in Schedule 1. The Publisher will notify the Licensee at least thirty (30) days in advance of any anticipated specification change applicable to the Licensed Material. If the changes render the Licensed Material less useful in a material respect to the Licensee, the Licensee may within

thirty days of such notice treat such changes as a breach of this License under clause 10.1.2;

- 7.2.2 provide the Licensee, within 30 days of the date of this License, with information sufficient to enable the Licensee to access the Licensed Material;
 - 7.2.3 use reasonable endeavours to ensure that the Server has adequate capacity and bandwidth to support the usage of the Licensee at a level commensurate with the standards of availability for information services of similar scope operating via the World Wide Web, as such standards evolve from time to time over the term of this License;
 - 7.2.4 use reasonable endeavours to make the Licensed Material available to the Licensee and to Authorized Users at all times and on a twenty-four hour basis, save for routine maintenance (which shall be notified to the Licensee in advance wherever possible), and to restore access to the Licensed Material as soon as possible in the event of an interruption or suspension of the service.
- 7.3 Collection and analysis of data on the usage of the Licensed Material will assist both the Publisher and the Licensee to understand the impact of this License. The Publisher shall provide to the Licensee or facilitate the collection and provision to the Licensee and the Publisher by the Licensee of usage data on the number of titles viewed, by title, on a monthly basis for the Publisher's and the Licensee's private internal use only. - 7.4 EXCEPT AS EXPRESSLY PROVIDED IN THIS LICENSE, THE PUBLISHER MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF DESIGN, ACCURACY OF THE INFORMATION CONTAINED IN THE LICENSED MATERIAL, MERCHANTABILITY OR FITNESS OF USE FOR A PARTICULAR PURPOSE. THE LICENSED MATERIAL ARE SUPPLIED 'AS IS'.
- 7.5 EXCEPT AS PROVIDED IN CLAUSE 7.1, UNDER NO CIRCUMSTANCES SHALL THE PUBLISHER BE LIABLE TO THE LICENSEE OR ANY OTHER PERSON, INCLUDING BUT NOT LIMITED TO AUTHORIZED USERS, FOR ANY SPECIAL, EXEMPLARY, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER ARISING OUT OF THE INABILITY TO USE, OR THE USE OF, THE LICENSED MATERIAL. IRRESPECTIVE OF THE CAUSE OR FORM OF ACTION, THE PUBLISHER'S AGGREGATE LIABILITY FOR ANY CLAIMS, LOSSES, OR DAMAGES ARISING OUT OF ANY BREACH OF THIS LICENSE SHALL IN NO CIRCUMSTANCES EXCEED THE FEE PAID BY LICENSEE TO THE PUBLISHER UNDER THIS LICENSE. THE FOREGOING LIMITATION OF LIABILITY AND EXCLUSION OF CERTAIN DAMAGES SHALL APPLY REGARDLESS OF THE SUCCESS OR EFFECTIVENESS OF OTHER REMEDIES. REGARDLESS OF THE

CAUSE OR FORM OF ACTION, THE LICENSEE MAY BRING NO ACTION ARISING FROM THIS LICENSE MORE THAN TWELVE (12) MONTHS AFTER THE CAUSE OF ACTION ARISES.

8. LICENSEE'S UNDERTAKINGS

8.1 The Licensee shall:

8.1.1 use reasonable endeavours to ensure that all Authorized Users are aware of the importance of respecting the intellectual property rights in the Licensed Material and of the terms and conditions of this License, and use reasonable endeavours to notify Authorized Users of the terms and conditions of this License and take steps to protect the Licensed Material from unauthorized use or other breach of this License;

8.1.2 use reasonable endeavours to monitor compliance and immediately upon becoming aware of any unauthorized use or other breach, inform the Publisher and take all reasonable and appropriate steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence;

8.1.5 keep full and up-to-date records of all IP addresses and provide the Publisher with details of such additions, deletions or other alterations to such records as are necessary to enable the Publisher to provide Authorized Users with access to the Licensed Material as contemplated by this License.

8.2 NOTHING IN THIS LICENSE SHALL MAKE THE LICENSEE LIABLE FOR BREACH OF THE TERMS OF THE LICENSE BY ANY AUTHORIZED USER PROVIDED THAT THE LICENSEE DID NOT CAUSE, KNOWINGLY ASSIST OR CONDONE THE CONTINUATION OF SUCH BREACH TO CONTINUE AFTER BECOMING AWARE OF AN ACTUAL BREACH HAVING OCCURRED.

8.3 The Licensee shall, in consideration for the rights granted under this License, pay the Fee within thirty (30) days of receipt of invoice.

9. UNDERTAKINGS BY BOTH PARTIES

9.1 Each party shall use its best endeavours to safeguard the intellectual property, confidential information and proprietary rights of the other party.

10. TERM AND TERMINATION

10.1 In addition to automatic termination (unless renewed) under clause 2.2, this License shall be terminated:

10.1.1 if the Licensee defaults in making payment of the Fee as provided in this License and fails to remedy such default within thirty (30) days of notification in writing by the Publisher;

- 10.1.2 if the Publisher commits a material or persistent breach of any term of this License and fails to remedy the breach (if capable of remedy) within thirty (30) days of notification in writing by the Licensee;
- 10.1.3 if the Licensee commits a wilful material and persistent breach of the Publisher's copyright or other intellectual property rights or of the provisions of clause 3 in respect of usage rights or of clause 6 in respect of prohibited uses;
- 10.2 On termination all rights and obligations of the parties automatically terminate.
- 10.3 On termination of this License by the Publisher for cause, as specified in clauses 10.1.1 and 10.1.3, the Licensee shall immediately cease to distribute or make available the Licensed Material to Authorized Users and shall return to the Publisher or destroy all Licensed Material locally mounted pursuant to clause 3.1.1 and 3.1.2.
- 10.4 On termination of this License by the Licensee for cause, as specified in clause 10.1.2 above, the Publisher shall forthwith provide electronic copies of the Licensed Material to the Licensee for hosting locally on a server within the Secure Network for access by Authorized Users under the terms of clauses 3 and 6 of this License, which shall survive such termination.

11. GENERAL

- 11.1 This License constitutes the entire agreement of the parties and supersedes all prior communications, understandings and agreements relating to the subject matter of this License, whether oral or written.
- 11.2 Alterations to this License and to the Schedules to this License are only valid if they are recorded in writing and signed by both parties.
- 11.3 This License may not be assigned by either party to any other person or organisation, nor may either party sub-contract any of its obligations, except as provided in this License in respect of the management and operation of the Server, without the prior written consent of the other party, which consent shall not unreasonably be withheld.
- 11.4 If rights in all or any part of the Licensed Material are assigned to another publisher, the Publisher shall use its best endeavours to ensure that the terms and conditions of this License are maintained.
- 11.5 Any notices to be served on either of the parties by the other shall be sent by prepaid recorded delivery or registered post to the address of the addressee as set out in this License or to such other address as notified by either party to the other as its address for service of notices. All such notices shall be deemed to have been received within 14 days of posting.
- 11.6 Neither party's delay or failure to perform any provision of this License, as result of circumstances beyond its control (including, without limitation, war, strikes, floods, governmental restrictions, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) shall be deemed to be, or to give rise to, a breach of this License.

- 11.7 The invalidity or un-enforceability of any provision of this License shall not affect the continuation or enforceability of the remainder of this License.
- 11.8 Either party's waiver, or failure to require performance by the other, of any provision of this License will not affect its full right to require such performance at any subsequent time, or be taken or held to be a waiver of the provision itself.
- 11.9 [This License shall be governed by and construed in accordance with _ (State)_____law; the parties irrevocably agree that any dispute arising out of or in connection with this License will be subject to and within the jurisdiction of the courts of _____County, _____.
