

## CRC Press/Taylor & Francis Group PERPETUAL LICENSE AGREEMENT

### 1. Definitions

In this Agreement the following words have the following meanings:

**Product:** CRC Press NetBASE or Taylor & Francis Encyclopedia

**License:** this Agreement between the Licensee and TAYLOR & FRANCIS GROUP, LLC.

**Order:** the order placed by the Licensee for the purchase of the **Database**.

**Licensee:** \_\_\_\_\_ organisation or the person, company or organisation named in the Order.

### 2. Licensee License

2.1 TAYLOR & FRANCIS GROUP, LLCTAYLOR & FRANCIS GROUP, LLC grants the Licensee a non-exclusive, non-transferrable perpetual access License to use the Database subject to and in accordance with the terms of this License. The Licensee acknowledges that the Database is the sole property of TAYLOR & FRANCIS GROUP, LLC. The Licensee confirms that it will only use the Database as permitted under the terms of this License. The Database is protected by copyright laws, intellectual property rights and international treaties.

2.2 The Database is defined as that content of titles accessible on the Database up to the date of this contract,

2.3 A one-time fee, in addition to an annual maintenance fee, payable to TAYLOR & FRANCIS GROUP, LLC permits the Licensee to access the Database of content, in perpetuity from remote Web access – the Licensee may have online search access to CRC Press designated web servers. If the online platform was no longer accessible or active, the Subscriber may, at its option, acquire, load and technically format on a server that enables access and use by Authorized Users through the Subscriber's internal secure network an electronic copy of the specified online book collection(s), provided that the Subscriber defrays the costs of preparing the data set sought, in accordance with the usage provisions of the Agreement, which provisions shall survive the termination of the Agreement. The electronic copy may not contain links and other features and functionality associated with the online version.

2.4 Any book titles or new editions added to the Database after this date of contract are not available in perpetuity unless either further fees are negotiated and contracted with TAYLOR & FRANCIS GROUP, LLC.

### 4. Use and Restrictions

4.1 The Licensee shall:-

(a) permit only the following categories of person to use the Database:-

(i) where the Licensee is a corporate or government organisation - members of its own staff, including bona fide consultants;

- (ii) where the Licensee is an academic organisation - staff, students, faculty and in-library users; or
  - (iii) where the Licensee is a public library - staff and in-library users;
  - (b) ensure that the Licensee's staff (including bona fide consultants) use the Database for the Licensee's own internal purposes only and that any other authorised users use the Database for research purposes only;
  - (c) provide users access to the Database at sites listed in paragraph 3 only and ensure that all users use the Database in accordance with the terms of this License;
  - (d) not modify, adapt, merge, publish, transmit sell, lend, rent, commercially exploit or make available to any third party (including any subsidiary, parent company or any other related or affiliated company or organisation) the whole or any part of the Database;
  - (e) not transfer, assign or sub-license this License.
- 4.2 Nothing contained in this License gives the Licensee or any Authorized User any rights in the Intellectual Property or confidential information of the Licensor in the Licensed Material.
- 4.3 The rental, loan, hire, purchase or distribution or dissemination, electronically or otherwise, by Licensee of Licensed Material is prohibited without the express permission of the Licensor.
- 4.4 For the avoidance of doubt, the Licensee may not incorporate all or any part of the Licensed Materials in Course Packs, Electronic Reserve collections or Electronic Learning Environments without the prior written permission of the Publisher or the Publisher's Representative, which may set out further terms and conditions for such usage.
- 4.5 A link to the Licensed Material may be incorporated in Electronic Reserve collections or Electronic Learning Environments.
- 4.6 Any alteration, amendment, modification or deletion from the Licensed Material, whether for the purposes of error correction or otherwise.
- 4.7 Neither the Licensee, nor any Authorized User, shall store transiently or permanently on any medium, transfer, transmit, reproduce, loan to any third party, publish or otherwise exploit, modify, or create derivative works from, or combine with other material, the Licensed Material except to the extent necessary to exercise the rights granted by any particular License. For the avoidance of doubt, neither the Licensee nor any Authorized User shall use the Licensed Material in whole or in part for the purposes of any external commercial re-use. The Licensee may, however, print out or make available by electronic mail limited portions of the Licensed Material for Authorized Users for the purposes of research or private study and not for commercial use. In addition, Licensee may fulfill requests from other institutions, a practice commonly called Interlibrary Loan. Licensee agrees to fulfill such requests in compliance with Section 108 of the United States Copyright Law (17 USC 108, "Limitations on exclusive rights: Reproduction by libraries and archives") and clause 3 of the Guidelines for the Proviso of Subsection 108(g)(2) prepared by the National Commission on New Technological Uses of Copyrighted Works.
- 4.8 Nothing in this Agreement shall limit the rights of the Licensee or any Authorized User to make fair use of the Licensed Materials, as that term is defined under Sections 107 and 108 of the Copyright Revision Act 1976.
- 5. Warranty and Liability**
- 5.1 TAYLOR & FRANCIS GROUP, LLC and the Licensee acknowledge that TAYLOR & FRANCIS GROUP, LLC supplies the Database on an "as is" basis. TAYLOR & FRANCIS GROUP, LLC gives no warranties as to its performance, functionality, freedom or errors, or that the Database will satisfy the individual requirements of the Licensee. Save as expressly provided in this License, TAYLOR & FRANCIS GROUP, LLC excludes all liability for any defect in the Database and for any loss or damage which the Licensee may suffer as a result of its use of (or inability to use) the Database or otherwise as a result of any breach of contract or negligence by TAYLOR & FRANCIS GROUP, LLC.

- 5.2 While TAYLOR & FRANCIS GROUP, LLC believes that the contents of the Database are an accurate representation or interpretation of the original materials from which the Database has been drawn, TAYLOR & FRANCIS GROUP, LLC does not warrant that the Database will be accurate, complete or error-free. TAYLOR & FRANCIS GROUP, LLC will not in any event be liable to the Licensee for any loss or damage of any kind suffered by the Licensee if the Database is found to contain any errors or to be incomplete or misleading in any way, whether as a result of TAYLOR & FRANCIS GROUP, LLC's negligence or otherwise.

- 5.4 TAYLOR & FRANCIS GROUP, LLC does not seek to exclude or limit its liability for personal injury or death caused by its negligence.

## 6. Termination and Breach

- 6.1 TAYLOR & FRANCIS GROUP, LLC shall be entitled to terminate this License by serving written notice on the Licensee if the Licensee:-
- (a) becomes insolvent, goes into liquidation, has an administrator or receiver appointed over any of its assets or enters into any arrangement with any of its creditors; or
  - (b) is in breach of any of these terms and conditions, and in the case of a breach which it is possible to remedy, the Licensee has not remedied the breach within 30 days of receiving notice from TAYLOR & FRANCIS GROUP, LLC specifying the breach.
- 6.2 Where TAYLOR & FRANCIS GROUP, LLC terminates this License in accordance with Clause 6.1, the Licensee shall cease all use of the Database and return all copies of the Database to TAYLOR & FRANCIS GROUP, LLC or demonstrate to TAYLOR & FRANCIS GROUP, LLC that it has destroyed all copies.

- 7.4 This License constitutes the entire agreement between the Licensee and TAYLOR & FRANCIS GROUP, LLC with respect to the use of the Database and supersedes all prior purchase orders, written terms and conditions, written or verbal representations, advertising or statements relating in any way to the Database. The Licensee shall not be entitled to rely on any representation or warranty other than those expressly set out in this License.
- 7.5 No modification or amendment to these terms shall be binding unless accepted by TAYLOR & FRANCIS GROUP, LLC and unless details are provided in writing by a person authorised to do so.
